- Couldn't name the justices only named one
- Background in healthcare
- Didn't know what constitutes quorum
- Said the definition of unethical conduct
- Doesn't believe the judges are completely impartial
- Believes that 3 days is enough time to prepare for a speedy trial
- Would believe that she would be available based on her course load
- Believes that the student has the final say by a 2/3 vote with the impeachment process
- 2 days is the amount a time for the court to release a written opinion of their decision
- Would be an asset based on her prior knowledge as well as life experiences and the SBA while handling cases
