D. Unfinished Business

- Title Revisions- Title 10

The Chairwoman begins by explaining to the new senators the revisions we have been working, and sent them the editable version of the document via FAMU email. Chairwoman decides for us to start back up at Chapter 904. Senator Leveille is chosen to begin reading the chapter to begin revision. It was changed under Point C to “5 Business days” for more clarity within the documents. Grammatical errors such as “had” and “forth” were corrected. Changed the beginning sentence in Chapter 905, to make more sense. It was changed from “fix” to “select” in chapter 906, and a comma was added because it was a run off sentence. In 906.7 “to the

student body was added,” so there would be no confusion on what was being announced. It was changed in 906.6 from “910.71” to “906.1” because there was no 910 in the chapter 900. Also changed “910.74” to “906.4” because as we said again there was no 910 in chapter.

E. New Business

- Title Revisions- Title 9

Pro Tempore Moricette arrives at the meeting to talk about his revisions to the CAB Sections. Begins explaining how previous Senator Nesbit began revisions on these chapters, and he picked up where she left off and added more revisions. Pro Tempore Moricette starts by showing the minor changes he made in the beginning of Title 9, and how he struck a couple subsections from Title 9. Duties were added for the Vice-Chairperson, Class Presidents, and Vice-Presidents just to give a sense of direction on what are the outlined responsibilities are. Senator McClinton gave a recommendation to change “1/3” to “2/3” for initiating impeachment in 805.3. Pro Tempore Moricette continues to explain changes and revisions done to Title 9. He added more things to “Research and Evaluation Committee,” for them to follow and conduct themselves accordingly. Senator McClinton and Leveille suggested that it be changed that CAB should meet during the first and last week of the month, with their discretion to choose the day of the meetings. It was recommended to add a CAB order of succession which shall be under 803.4 and it shall follow as Chairperson, Vice-Chairperson, Secretary, Parliamentarian, and Assistant Secretary. Senator Jean-Baptiste motions to accept this piece of legislation with said recommendations, Pro Tempore Moricette 2nd.
