Whereas,	The University Counseling Services is an amazing entity to the student body and have handled over 75 crisis services this school year alone, and
Whereas,	The counseling services do not have the traveling equipment required to travel on campus at times. Even though many of the crisis services require the counselors to travel across campus to accompany our students at need in a timely manner, and
Whereas,	Equipping the counseling services with funds to purchase a golf cart will benefit the student body in many ways such as. Allowing the counselors to report to crisis incidents in a timely manner which can be the difference from saving or losing a fellow rattlers life, now
Therefore,	Be it appropriated, eight thousand four hundred twenty-seven dollars and ninety-eight cents \$8,427.98 to the University Counseling Services to aid them on maintaining and improving the mental health of the student body whether it be critical or minor.




