Whereas,	The Florida Agricultural and Mechanical University Student Senate is the Legislative Branch of the Student Government Association and is empowered to pass legislation as it deems necessary to carry out the functions of the Student Government Association, and
Whereas,	The Venom Dancers is a dance organization that strives to promote and uphold school spirit, develop strong sportsmanship between FAMU students and alumni while enhancing the overall game day fan experience by performing at athletic events and national competitions, and
Whereas,	Adequate funding remains an issue for the Venom Dancers as they strive improve their presence in the performing arts realm outside of FAMU by incorporate new choreography into daily routines in order to continue to enhance the game day experience for fans, and
Whereas,	The Venom Dancers participating in the P-R-O Convention in Atlanta would help to bring recognition to performing arts organizations here at FAMU as it is one of the largest conventions for professional cheerleaders and dancers; The members participating in this convention will bring innovative choreography to the team to help elevate the performances overall, now
Therefore,	<u>Be it Appropriated,</u> six thousand eight hundred thirty-two dollars (\$6,832.00) to the Venom Dancers.

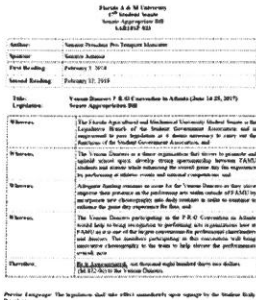
