| Therefore, | Be it enacted that Title IV in the Florida A&M University Student Body Statutes be adopted as follows: | | |

Chapter 300

Organization of the Senate

300.1

The Senate shall meet at least three times each month of the academic year.

300.2

Senate Offices

- 1. The Following shall be elected by the majority vote from within the membership of the Senate
- 2. The President Pro-Tempore, elected by a majority vote of the Senate, shall assist the president in his/her duties and preside in the absence of the President.
- 3. The Chaplain/Parliamentarian shall be the chairperson of the Judicial and Rules Committee
- 4. The candidates for Secretary and Assistant Secretary of the Student Senate shall be interviewed by the Senate Executive Committee appointed by the Senate President from outside the Student Senate and confirmed by the Senate by a two-third (2/3) vote.
 - a. The positions shall be advertised for 10 business days within 10 business days of the Senate President being elected by the Student Senate. The positions must be advertised in at least 3 official University information outlets such as the FAMUAN, FAMU Forward, and the University email system.
